# **Eligibility requirements**

General admission requirements:

As a basic eligibility requirement, the applicant must be enrolled as a doctoral student.

Specific admission requirements:

Students enrolled in a PhD programme with equivalent experience and knowledge in performative and/or media-based practices and Black Studies.

#### Selection

If there are more eligible applicants than available places there will be a selection based on how well the applicant situates their practice in relation to Black Aesthetics. Special consideration is given to artistic experience/activity with a focus on and/or related to the course content. Students who have passed Philosophical Aesthetics in Black Study are guaranteed a place.

## **Course Content**

Through the course's study materials and methods, the student will deepen their own research problems/questions through the specific criticality and terminology that the fields of black aesthetics and performance study offers while discussing the interdisciplinary nature of both black study and artistic research. The methodological focus is how to relate to these companion thinkers in the process of creating and researching through art practice.

Theories and strategies from the study material are starting points for creative thinking about how aesthetics and concepts of the social interact in the student's project, with a focus on the ethical implications of this interaction. The student also creates a personal list of reading/watching/listening relevant to their practice.

# Learning objectives

After completing the course, the doctoral students shall:

- demonstrate specialised insight into the possibilities and limitations of art, its role in society and the responsibility of the individual for how it is
  used.
- · discuss the strategies and knowledge acquired at the intersection between their own study of theory and their own practice,
- · demonstrate intellectual autonomy, artistic integrity and disciplinary rectitude as well as the ability to make assessments of research ethics.
- demonstrate the ability to identify the need for additional knowledge.

# Course requirements

Attendance, preparation according to schedule as well as active participation in lectures, seminars and other activities are required in order to complete the course.
