### **Eligibility requirements**

General entry requirements for studies on first cycle, with exemption from Swedish 1, 2, 3.

Specific entry requirements:

120 credits in artistic subject with specialisation in bodily and vocal practices for performing arts or the equivalent.

### **Selection**

If there are more eligible applicants than places available, a selection will be made. The selection is based on a combined assessment of eligible applicant's documented merits and a work sample in the form of a submitted project idea. The following criteria form the basis for assessing the applicant's ability to benefit from the course:

- The applicant's project idea with regard to relevance, originality, feasibility and the university's ability to provide adequate supervision.

### **Language of instruction**

## **Course Content**

Students will carry out artistic development work under the supervision of teachers. Some technical supervision will also be included. During the course, students present their work based on the idea, process and result.

During the course, students work and practice independently and participate in artistic supervision in groups with teachers. Students are responsible for providing feedback on at least one other student's artistic development work. This takes place continuously during the course and in connection with practical presentations in each module.

The course consists of the following modules:

### **Theme, Aim, and Method, 15 credits**

In the module, the student, together with the supervisor and the group, works out the theme, aim and method in their artistic development work.

### **Implementation and Presentation, 15 credits**

In this module, students independently implement their artistic development work.

## **Forms of teaching**

Lectures, seminars, workshops, individual coaching, one-to-one supervision, group supervision, teacher-led training.

## **Learning objectives**

### **Theme, Purpose, and Method, 15 credits**

After completing the course the student is able to:

1. independently develop an artistic idea,
2. develop and discuss methods that are relevant to their artistic idea.

### **Implementation and Presentation, 15 credits**

After completing the course the student is able to:

3. carry out and present an artistic development project that integrates technical skills with artistic ideas and is based on process and results,
4. give feedback on other students' work in different phases of an artistic development project,
5. reflect on their artistic process.

## **Examination**

### **Theme, Aim, and Method, 15 credits**

(1001) Practical presentation, 10 credits, regarding learning outcomes 1, grades Fail (U) or Pass (G)

(1002) Oral seminar, 5 credits, regarding learning outcome 2, grades Fail (U) or Pass (G)

### **Implementation and Presentation, 15 credits**

(1004) Oral seminar, 5 credits, regarding learning outcomes 4-5, grades Fail (U) or Pass (G)

If there are special reasons, the examiner may, after consultation with the course teacher, allow the student a re-examination opportunity where the student is examined through another but pedagogically equivalent form of examination. Each case is assessed individually.

If a student has a decision from Stockholm University of the Arts about special pedagogical support due to functional variance, the examiner can decide on alternative forms of examination in consultation with the student.
