Entry Requirements

General Entry Requirements:

for studies at the first cycle with the exception of Swedish 1, 2 and 3.

Specific Entry Requirements:

30 credits in the main areas of Performing Arts and Media, Circus, Dance, Dance Pedagogy Choreography or Opera, or equivalent.

Selection

Programme students: By drawing of lots according to the student's own choices and order of preference regarding courses.

Language of Instruction

The main language of instruction is English.

Course Content

The course takes the student into a journey in time and space towards the suburbs of our filmic heritage, to trace early forms of artistic research practices in film. By looking into historical and contemporary examples the student will trace a genealogy of practices expanding the aesthetic boundaries of film as a medium. With the student, the course relocates artistic research in film beyond an academic discipline and as a part of politically engaged art practice.

The course is organized around collective seminars, where the student will present and reflect on their researched material and discuss it with the group. Reading will mainly consist of texts by filmmakers.

- 3. establish a theoretical and aesthetic frame for their own work.
